Re: Kansas Open Records Act Complaint:

We write on behalf of the Kansas Chapter of Americans for Prosperity Foundation ("AFPF"), a 501(c)(3) nonprofit organization committed to educating and training Americans to be courageous advocates for the ideas, principles, and policies of a free and open society. AFPF respectfully requests the Office of the Attorney General require the Kansas Department of Commerce ("Commerce") to provide the final batch of records responsive to AFPF's Kansas Open Records Act ("KORA") request, which AFPF submitted over one year ago. For the last seven months, Commerce has not only failed to produce those records, which appear to be e-mails from the accounts of Commerce Secretary David Toland and his chief of staff about a controversial economic development program, but the agency has not offered any detailed explanation for the delay.

AFPF's November 4, 2021 KORA request sought information about the Commerce-run Sales Tax and Revenue ("STAR") Bonds financing program that allows private development projects to be financed by government bonds backed by taxpayers. The STAR Bond program creates an unfair advantage for privileged businesses and there is scant evidence that they are accomplishing their stated objectives. An <u>audit</u> by the Kansas Legislative Division of Post Audit raises serious concerns about the projects funded by STAR Bonds and potential harm to taxpayers.² Previous studies have also questioned the claims of job creation from the STAR Bonds program.³

The AFPF KORA Request

Pursuant to the KORA, Kan. Stat. Ann. § 45-215 et seq., <u>AFPF requested</u> the following records from Commerce on November 4, 2021 (attached as Exhibit 1):

- 1. All internal or external reports, including those commissioned or contracted, which examine the STAR Bonds financing program from 2007 to the present.
- 2. All STAR Bond feasibility studies from 2007 to the present.
- 3. All e-mail communications regarding the STAR Bond financing program sent to or from the following employees between January 1, 2021 to September 1, 2021:
 - a. Secretary of Commerce
 - b. Chief of Staff
 - c. Chief Counsel

<u>Timeline of Responses from an Attorney for the Kansas Department of Commerce</u>

- **November 10, 2021**: Commerce acknowledged receiving AFPF's KORA request and advised it the agency is extending its response to November 19, 2021. (Exhibit 2)
- **November 19, 2021**: Commerce again extended its response until December 6, 2021. The agency also asked for \$500 in fees before working on the request. (Exhibit 3)
- **December 6, 2021:** Commerce noted it had not yet received AFPF's \$500 payment and that the agency anticipates "it will take 15 days after we have received your payment for Commerce to fully complete your request." AFPF proceeded to pay the \$500 fee to Commerce. (Exhibit 4)
- **January 21, 2022**: Commerce extended its response a third time until February 4, 2022. (Exhibit 5)
- **February 4, 2022**: Commerce advised it would send the first batch of records by February 7, 2022 but extended its response for all remaining records until March 4, 2022. (Exhibit 6)
- **February 14, 2022**: AFPF received the first batch of records. The production included STAR Bond Feasibility studies as requested under Item 2 of AFPF's request. (Exhibit 7)
- March 4, 2022: Commerce provided a second interim release for documents responsive to Item 1 of APFF's request. (Exhibit 8)
- **April 1, 2022**: Commerce again extended its response of the "final collection of records" until April 29, 2022. (Exhibit 9)
- April 29, 2022: Commerce provided a link to a record production with responsive records to Item 3 of AFPF's request—namely, e-mails from Commerce's Chief Counsel. The agency also extended its response for the remaining records until May 27, 2022. (Exhibit 10)
- May 27, 2022: Commerce extended its response a seventh time until June 30, 2022. (Exhibit 11)
- July 1, 2022: Commerce extended its response an eight time until July 31, 2022. (Exhibit 12)
- **July 30, 2022**: Commerce extended its response a ninth time until August 19, 2022. (Exhibit 13)
- **August 27, 2022**: Commerce extended its response a tenth time until September 30, 2022. (Exhibit 14)
- **September 30, 2022**: Commerce extended its response an eleventh time until October 28, 2022. (Exhibit 15)
- November 29, 2022: When asked for an update on the processing of AFPF's request, Commerce responded without setting a date certain: "We are still working on processing the final part of this request. I'll be in touch when that is complete." AFPF responded to Commerce's communication on December 2, 2022 with a request for more information: "Does the agency have a more detailed explanation for the continued delays in processing the final part of this request? The last record production occurred over 7 months ago on April 29, 2022." AFPF has yet to receive a response to this question as of December 7, 2022. (Exhibit 16)

Relief Requested

AFPF requests that the Kansas Department of Commerce process the final responsive records and provide them to AFPF in electronic format within the next 10 working days. Further, we respectfully request the Attorney General's Office open an investigation into how Commerce

responds to KORA requests—including AFPF's request at issue here. This is not the first-time complaints have been made about how the Department of Commerce handles KORA requests related to its economic-development programs.⁴

We write on behalf of the Kansas Chapter of Americans for Prosperity Foundation ("AFPF"), a 501(c)(3) nonprofit organization committed to educating and training Americans to be courageous advocates for the ideas, principles, and policies of a free and open society. Economic development programs like the Kansas Department of Commerce-run Sales Tax and Revenue ("STAR") Bonds financing program create an unfair advantage for privileged businesses and impose costs on taxpayers. A recent <u>audit</u> by the Kansas Legislative Division of Post Audit raises serious concerns about the projects funded by STAR Bonds and potential harm to taxpayers. Previous studies have also questioned the claims of job creation from the STAR Bonds program.³

Pursuant to the Kansas Open Records Act ("KORA"), Kan. Stat. Ann. § 45-215 et seq., AFPF hereby requests the following records:

- 1. All internal or external reports, including those commissioned or contracted, which examine the STAR Bonds financing program from 2007 to the present.

Request for a Public Interest Fee Waiver

AFPF requests a waiver of any and all applicable fees. The KORA gives agencies discretion on whether to charge fees, noting that a "**public agency may charge** and require advance payment of a fee for providing access to or furnishing copies of public records, subject to K.S.A. 45-219." Kan. Stat. Ann. § 45-218(f) (emphasis added).

AFPF's KORA request is in the public interest because the records requested would shed light on the activities of government and AFPF intends to educate the public with the results of this KORA request. Further, AFPF is a non-profit organization as defined under Section 501(c)(3) of the Internal Revenue Code, and it has no commercial interest in making this request.

If fees cannot be waived, AFPF authorizes the Kansas Department of Commerce to fulfill this KORA request and bill AFPF for any fees, provided the amount does not exceed \$100. If processing this request will cost more than \$100, please contact AFPF before proceeding.
