



- Ask partner groups—the City, the school district, groups who use Library facilities to meet or to do their work—to include the link and/or the QR code in electronic communications with their members.
- Use your Facebook account, email, and text lists to remind your own constituent groups about the survey and its importance.
- Keep flyers and/or a display with the QR code at the circulation desk, so that all patrons have an opportunity to complete the survey.

There's still plenty of time to drive participation in the survey, but there's a way to go to reach 400 responses, which we think is the threshold number for a reliable indicator of public opinion.

He uses library services but about 1/10 as much as I do. I was disappointed that there were no opportunities for general comments. I voted in favor of the library in the last referendum. I live on the edge of the library district, equally distanced from Rochester and Chatham libraries. I use the Chatham library almost exclusively because it is "on the way to other errands" and because it is larger. I use the library a lot. (I'm really using the Rochester card, of course, to use all the libraries in the System.) Since we retired we love to go to Chatham to work jigsaw puzzles, browse, etc.

I voted for the expansion because it is so completely clear that Rochester library is working hard but uphill. Not enough room. Not enough money for digital books. Website is not as easy to navigate and full of information as Chatham's. When my granddaughter was a toddler (she's 13), I took her to Rochester because she was in love with the playhouse. I loved the read to the dog events. During the lead up to the last referendum, there was not a single sign in any part of my East Lake Shore Dr. neighborhood. Maybe the focus is not spread to the edges of the district, where potential votes live. How many patrons check out from other libraries using Rochester cards? Where are those folks?

I appreciate every staff member I've ever encountered at Rochester Library. They are service-oriented and knowledgeable. I hope you are successful in your funding effort. Thanks for listening.

Tax Levy — Inflation

- The Rochester Library has not had an operational budget increase since 1995. The operational budget has lagged behind inflation as shown in this graphic.
- The tax levy is the primary source of the library's operational budget funding. Example: 2023-2024 tax levy is \$473,886 and budget amount is \$572,271.
- As this chart shows, inflation has increased at a faster rate than the tax levy.
- 4.84% of the 2023-2024 operational budget for the Rochester Library comes from the tax levy and 16% from grants and donations.

I think that will make things clearer—anyway, that's my 2 cents worth for the Vote Yes Group. Please tell them that I am willing to help create any power points that they might like for public presentation purposes.

PS: One thing to point out to any senior citizens in the audience and those that qualify for the homestead exemption—the value of the two is an \$11,000 reduction in the property tax value. 



These are some of the common myths that you may encounter when you begin to discuss funding issues with community members. We've provided some suggested "reality checks" that you can employ in response.

Myth: My library has plenty of money—it just opened a new computer lab.

Reality: Many public libraries receive local, state and federal grants to pay for everything from renovations to specific programs. These dollars cannot be used for anything but what's specified in the grant.

Myth: Why would my library need money? We passed a levy only a few years ago.

Reality: Operating levies and referendums usually aren't indefinite and often expire within five to ten years. Your library may be renewing the current levy or asking for additional funding based on future need or to offset cuts in state or federal funding.

Myth: Libraries have too many employees—can't they save money by letting some of them go?

Reality: There is a lot that goes on at a library besides what patrons see —such as planning, purchasing, cataloging, training, marketing, maintenance and community partnership activities. Also, keep in mind that many of the helpful people you see stacking books or assisting with classes are volunteers.

Myth: A new library building means that the library has loads of money in its budget.

Reality: Most libraries have a capital budget, for maintenance or expansion projects, and an operating budget, for staff salaries and other operating expenses. Also, the money used to build the new library was probably a combination of a separate levy, donations and grants.

Myth: Now that libraries have e-readers and other Internet-based technology, they can downsize to save money.

Reality: All of the new technology now available through your local library costs money and, often, creates many ongoing charges—and the need for more technology-savvy staff. Also, access to this technology has increased library traffic, making it even more important to maintain and evolve the library building and staff skills.

Myth: Public library funding is the state's responsibility.

Reality: While state money does help support local libraries, these dollars can be inconsistent and prone to cuts—and for most libraries, a very small portion of the overall budget. Local dollars make up the majority of budgets for almost all American public libraries.

Myth: The busier the library, the more money it receives.

Reality: Unfortunately, library funding is not based on use or demand. Most libraries work on annual budgets based mainly on city or county allocations, or property tax allocations.

Myth: The federal government funds U.S. public libraries.

Reality: Actually, the vast majority of library budgets come from local sources—state and federal dollars usually make up the smallest portion.

Myth: I'm already funding the library by paying my late fees and purchasing items at book sales.

Reality: Late fees and book sale dollars provide a very modest contribution to libraries and support replacement of materials lost or items not returned. Fees and fines are not sufficient to support operating or program activities.

Myth: Every public library in the U.S. is funded in the same way.

Reality: Even though all public libraries are funded by some combination of local, state and federal dollars, the mix is unique. To learn more about how your library is funded, contact your local library.

Myth: Libraries use private donations for extras.

Reality: Some do, but many libraries across the U.S. report that they are also starting to use non-tax revenue, such as donations, to help pay for critical budget items like staff salaries and collections.

Myth: If I do not vote in support of a library operating levy or referendum, other funding from the state or federal government will make up the difference for my library.

Reality: When a library or library system loses a local operating levy or referendum, it can mean cuts in programs, staffing and collections or closing its doors. In the majority of cases, there is no mechanism for state or federal funding to supplement local support.





I saw the discussion on Who's Your Teacher this morning; perhaps there are others as well. The discussion I read was reasonably rational except for a couple of comments about wanting an increase to protect jobs.

I realize that what I have attached may be playing with fire and might well inflame the passions, but I think it is time to throw a dose of hard reality to those who are saying no, to those who claim to love the library but are opposed to a tax increase, to be blunt with the group (s) opposing the tax increase.

Based on comments at the last Vote Yes Meeting I attended, this is the lay it on the line communication that I propose—for the Vote Yes Page, for Whose Your Teacher, Talk Rochester, etc.

And, yes, it might blow back in our faces should we go back, in April, for strictly an operating budget increase. To paraphrase scripture, forgive the naysayers, for they know not what they do.

The Consequences of a No Vote!

The following are the consequences, effective January 1, 2025 (or earlier) should the November 5th referendum fail. The RPLD Board will have no choice, but to implement:

- 15% to 20% reduction in operating hours, from 51 to 44-41
 - No possibility of extended hours or Sunday hours
- 20% reduction in staff, 10 to 8
- NO Farmers Market or Fall Festival
- 50% reduction in publicly available computers, 8 to 4
- 50% reduction in hot spots (Portable internet terminals), 20 to 10
- 50% reduction in programs, 283 to 140 or possibly fewer
- 50% reduction in program participants, from nearly 4,000 to under 2,000
- 50% reduction in summer reading program, 8 weeks to 4 weeks with corresponding reduction in prizes
- 100% elimination of all subscriptions/subscription services
- No additional spaces for private tutoring, zoom meetings, community groups
- Reduction or elimination of partnerships with Rochester Schools, Carriage Crossing, Home Schoolers, and other community groups
- Reduction in new book acquisitions

Significant, additional cuts will be made when the 2025-2026 RPLD Fiscal Year begins July 1, 2025.
